Acknowledgment of Inherently Dangerous Activity

By participating in this Course, I acknowledge the inherent dangers and risks involved in Fast Rescue Boat training. This Course involves my exposure to working in a hazardous environment using personal protective equipment, lifesaving equipment, using many varied hand and power tools, operating cranes and davits, working near and on bodies of water both inland and offshore, may require me to lift as much as 50lbs, exposure to slick surfaces, exposure to adverse weather and sea conditions, intense bright sunlight, heat and humidity typical to South Florida, exposure to aquatic and terrestrial animals, loud noises and other dangerous activities that are inherent to Fast Rescue Boat training.

I acknowledge that this training may result in injuries. Such injuries may range from minor to life threatening injuries, including death. I am responsible for minimizing the risk of injury by following any and all rules established and administered in both written form and orally announced by my instructors. I must at all times: (1) immediately report any unsafe condition I may observe to my instructor; (2) be aware of my surroundings and inspect all protective gear and equipment for defects; (3) be alert and recognize any indication of fatigue or disorientation I or others may be experiencing that could pose a risk to my safety; and (4) voluntarily remove myself from this Course at any time in order to avoid injury. I assume full responsibility for the dangers and risks inherent with Fast Rescue Boat training, including the risk of bodily injury and property damage.
